This insurance for the additional insureds shall be as broad as the coverage provided for the named insured subcontractor. It shall apply as Primary and Non-Contributing Insurance before any other insurance or self-insurance, including any deductible, maintained by, or provided to, the additional insured. Subcontractor shall maintain CGL coverage for itself and all additional insureds for the duration of the project and maintain Completed Operations coverage for itself and each additional insured for at least 3 years after completion of the Work.

- j. Contractor and Subcontractor waive all rights against (1) each other and any of their Subcontractors, agents and employees, and (2) The Owner, its agents and employees, for damages caused by fire or other perils to the extent covered by property insurance provided under the General Agreement or other property insurance applicable to the Work, except such rights as they may have to proceed of such insurance held by owner as fiduciary. Subcontractor shall require of its Sub-subcontractors and their agents and employees, by appropriate agreement, similar waivers.
- k. To the fullest extent permitted by law subcontractor waives all rights against Contractor, Owner and Architect and their agents, officers, directors and employees for recovery of damages to the extent these damages are covered by commercial general liability commercial, commercial umbrella liability, business auto liability or workers compensation and employers liability insurance maintained per requirements stated above.
